Voters' Assembly Minutes

May 16, 2021

The regular meeting of the voters' assembly of Hope Lutheran Church was called to order on May 16, 2021, at 11:32 a.m. MDT by the president, Christopher Becker; the secretary was present. A quorum was established; a list of voting members present is attached.

Christopher read a devotion and led the opening prayer.

Due to Covid-19 we have not approved minutes for a year. The minutes of the May 31, 2020, August 2, 2020, November 22, 2020, February 7, 2021, March 7, 2021, and March 25, 2021, minutes were approved as emailed.

The treasurer's and board and committee reports were emailed ahead of the meeting and were available in hard copy. They are attached.

For the Board of Elders, Jim Oloff asked the voters' opinions on relaxing Hope's Covid-19 measures such as maintaining distance between congregants by roping off pews, serving communion to a procession rather than at the rail, and requiring masks to be worn at some events. He will relay the voters comments to the Elders.

For the Board of Property, Nancy reported that the signs to implement the policy on unscheduled use of the grounds are in production.

Transition to Proposed Constitution and Bylaws

The following resolution, presented by direction of the board of directors, was adopted:

- *Whereas*, the Northwest District Board of Directors may approve our proposed constitution and bylaws soon;
- *Resolved*, That our proposed constitution and bylaws go into effect on September 1, 2021, or the first of the month following receipt of Northwest District approval, whichever comes later;
- *Resolved*, That all applications for voting membership from communicant members over 18 years of age received by the close of the May 16, 2021, voters meeting be accepted and that those members be enrolled as voters under the new bylaws;
- *Resolved*, That the secretary's term be extended one year, until July 31, 2023;
- *Resolved*, That the day school treasurer be elected on May 16, 2021, to a one-year term and that service through July 31, 2022, not be count in the term limit;
- *Resolved*, That Strategic Planning Committee Members-at-Large be elected in November 2021, with the Position A member's term extending to July 31, 2022, (and service to July 31, 2022, not counting in the term limit) and the Position B member's term extending to July 31, 2023;
- *Resolved*, That Elders select approximately half of their members to be affirmed in odd years, half in even years, and that the "odd year" elders be presented for affirmation in November; and
- *Resolved*, That Director of the Board of Elders elected on May 16, 2021, serve an approximately one-year term and be eligible for nomination and election under the new bylaws in 2022.

Thirty applications for voting membership were received; the list of communicant members accepted into voting membership by this resolution is attached.

Regional Council for Christian Ministry

It was moved by JoAnn Jepsen and seconded to withdraw from the Regional Council for Christian Ministry. (Her handout is attached.) The motion carried; the president, director of the board of elders, and pastor will inform the RCCM executive board of our decision.

Forum

Christopher asked for an expression of interest on holding a forum for congregation members to express their opinions. He will share the response with the new board of directors in July.

Committees Created by the Voters

The following resolution, presented by direction of the board of directors, was adopted:

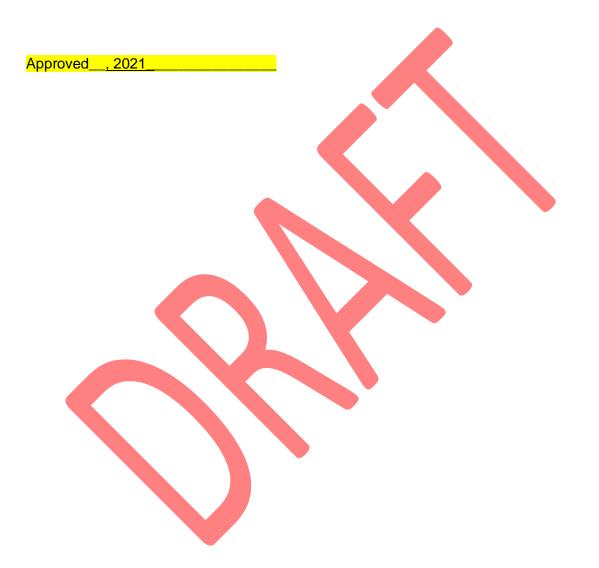
- *Whereas*, in August 2019 the voters formed four committees, Building and Expansion, Benefits, Church and School Staffing, and Church and School Security Committee, with the members' terms expiring in August 2021;
- *Whereas*, the duties of the Building and Expansion and Church and School Staffing committees fall within those of the Strategic Planning Committee to be created under the new bylaws; and
- *Whereas*, the Church and School Security Committee would more accurately be named the Safety Committee;

Resolved, that the Building and Expansion, Benefits, and Church and School Staffing committees be discharged; and

Resolved, that the Church and School Security Committee be renamed the Safety Committee and that on August 1 the terms of the existing members expire and thereafter members are appointed in accordance with the new bylaws.

The meeting adjourned at 1:05 p.m. MDT with the Lord's Prayer.

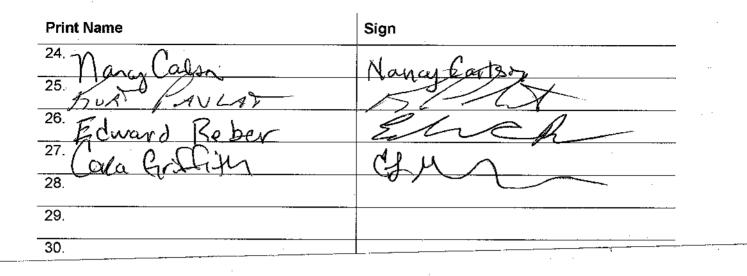

Covid 19 Pandemic

- March 22 and 29 worship services will be by appointment. Pastor will do a 20-minute service with communion every thirty minutes from 9:00 to 12:00. Each service will be limited to 10 people. Worshipers are asked to call the office or email to reserve a time. Sunday morning Bible class was suspended.
- On March 28, 2020, the Elders suspended the March 29 public worship service by appointment in response to the stay-at-home order issued by the Governor of Idaho. The service will be recorded and posted to the website and Facebook.
- Worship Services: April 5, 12, 19, 26, May 3, recorded and posted online. Included Holy Week Services, and Easter Sunday.

Staff Update

- Rather than one person as school administrator we have an Administrative Team:
 - Pastor Pay: Staffing, Team Building, Enrollment, Congregational Liaison, Day-to-Day
 - Shawnee McKinnon: Parent interaction, Child behavior, Early Childhood Lead, Summer program lead, Tours, Day-to-Day
 - o Bryan Northcutt: Enrollment, Curriculum, Elementary Teacher Lead, Day-to-Day
- Becky Reber will not be returning next year.
 - We thank her for her service in a very complex first year and look forward to her possibly working in a part-time capacity with the children
 - We have an applicant for the 3-4th grade job but are doing a bit more searching before extending a contract
- All other staff are returning and we hope to get contracts out with a revised pay scale by the end of this month
- Documents for Bryan's colloquy were submitted
- We are looking to add part-time aides (4 hours a week) to help with multigrade teaching anyone interested?

Financials

- Ed Reber, our newly elected day school treasurer, is working on reconciling finances. Ron Clayton, the immediate past day school treasurer, is working on reconciling last year's accounts—he is up through August.
- As of May 4, 2021, there was \$23K in the school's checking account, \$74K in school savings, and \$18K in school reserves. (Does not include assets from Phyllis Berry's estate or PTO accounts.)

Enrollment

• Current enrollment: 60 students, 38 in K-6 and 22 in early childhood

- Enrollment Projections
 - Pastor took TADS training and opened enrollment for next year. We had three applications last year in April, we had 11 this year. We gained the most applications (by far) in August of last year, we are hoping for a similar increase. However, we may get fewer in August this year, as Covid may have sent some families our way because of public school responses to Covid.
 - We have a total of 22 students enrolled for next year; as usual there are smaller numbers in the upper grades.
 - We project a FULL early childhood program (Modular anyone?) and kindergarten already has 9 students enrolled.

Board of Stewardship—Roger Henry

Various announcements and emails were made throughout the year. Focus has been on encouraging members to be Eph 2:10 Christians by putting their faith into action/service with an emphasis the process of "head to heart to hands" and being more outreach- and service-oriented to our members and neighbors. Copies of Max Lucado's book *Anxious for Nothing* were distributed to the congregation to help address the anxiety many were experiencing from the concerns of the pandemic. The 40 Day Challenge book was also made available to the congregation. At Easter, a booklet called *The Case for Easter* by Lee Strobel were made available for members to share with friends and family who may not know Christ. Another booklet called *The Case for Christ* by Lee Strobel was also distributed to the congregation. These booklets were intended to be resources for those doing the 40-day challenge, which included the challenge to share the message of Christ with five people (Day 38).

Board of Church Property—Lindy Roth

- Minor repairs to the exterior of the church included fixing fascia trim, door stop repair, leveling doors, etc.
- Replaced the 4 ft fence with a 6 ft fence at the south side of the west parking lot to close off the play yard and soccer field.
- Replaced concrete on the west side of the building.
- Seal coated the parking lot areas with cracks to extend the life of the asphalt.
- Updated building locks giving us the ability to issue keys to people to access unique areas of the building based on need.
- Started the conversion of lighting to LED as old fixtures fail.
- Sound system issues resolved with the assistance of Phase 4.
- Idaho Falls Water has installed water meters so we need to start planning on water conservation measures to reduce our bill which will be hefty in the summer months.
- Started furnace project in late 2020 to provide easy access to filters so they can be replaced per a planned maintenance schedule to extend the life of our furnaces. Project completed in April 2021 as the COVID caused a supply chain disruption in needed materials.

Board of Youth Ministry—Betty Oloff

We began 2020-2021 with about eleven youth, newly confirmed through high school students. Pastor sent a letter to each of the families with children going into ninth grade through twelfth grade describing activities planned for the school year and a calendar of tentative dates for activities. These included monthly *Campfire with Pastor* chats as well as social and service activities. The youth

- Had a picnic and hike at the rest area on I-15 south of Idaho Falls
- Raked Dennis and Becky Keiser's yard. (The girls divided the money Becky paid.)
- Filled the bags given out to children at Christmas Eve and Christmas Day services. We had enough to bring 35 bags to The Haven after Christmas for those children.
- Went sledding at Freeman Park.
- Filled Easter bags with booklets from The Lutheran Hour and candy and toys.

Around 17 students will or may attend Camp Perkins this summer; scholarship money will be paid to Camp for most of those families. A church/school garage sale is planned for Saturday, May 8. Proceeds will be used for scholarships to Camp Perkins in 2022.

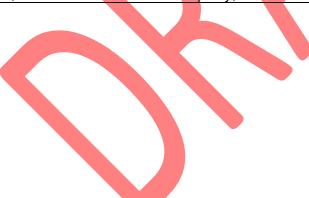
Report on Facility Use Motion—Myrtle Siefken, secretary

The February 2021 the voters meeting was asked "Is it the sense of the voters that we should allow the gates to be open during non-school daylight hours for unrestricted use with no Hope member present. Shall the Board of Directors be instructed to insert a section into the Facility Use Policy allowing such use?" The motion carried. In response, Nancy Carlson, Dave Van Haaften, and Kurt Pavlat were appointed to work with Myrtle Siefken to draft a policy and implementing steps (signs, administrative procedures, etc.).

The committee drafted proposed policy amendments and signs to post on the fence, had the language reviewed by an attorney, and presented the results to the Board along with a suggested procedure and forms for carrying out the policy. The policy was adopted by the Board; a minor change was made to the sign wording. Sign vendors have been contacted and that information is scheduled to be presented to the Board on May 11.

Regional Council for Christian Ministry (RCCM)

Hope Lutheran is a member church of the Regional Council for Christian Ministry (RCCM) and it is being proposed that we withdraw our membership.

BACKGROUND:

Hope Lutheran Church is currently a member church of The Regional Council for Christian Ministry, Inc. (RCCM). RCCM is a 501(c)(3) non-profit, religious corporation that was organized in 1967 by local churches in the greater Idaho Falls area. Its purpose is to coordinate programs in <u>Christian</u> education, service, and outreach in the greater Idaho Falls area. RCCM houses three standing committees that operate outreach: Island Park Ministry, Community Food Basket—Idaho Falls, and Friends in Service Here (FISH).

REASONS TO WITHDRAW FROM RCCM:

RCCM is fundamentally a good organization and does much for the community. However, it appears that it is becoming less faithful to the Scriptures. There is increasing involvement of non-Christian individuals and organizations who are becoming very influential and partnering with RCCM to participate in joint-led activities (even though some of the activities are worthwhile).

We are not to become unequally yoked with unbelievers . . . (2 Corinthians 6:14). Examples:

- RCCM is partnering in functions, activities, and worship with the "Idaho Falls Interfaith Community" which is open to all area churches, including ones that are non-Christian. While this group supports some worthwhile local efforts, it also is host of the Interfaith Thanksgiving worship services and has been supportive of some liberal political events.
- Currently, 50 percent of the RCCM member churches are pastored by women, which is certainly not "faithful to the Scriptures." 1 Timothy 3:1-7 and Titus 1:5-9 tell us that the qualifications of a pastor (elder, overseer, pastor) are only fulfilled by men.
- A couple from the LDS church have been added as ex-officio members. That couple is becoming increasingly influential within the RCCM and they have recently been placed on the Community Food Basket board.
- An objection has been raised as to RCCM's involvement with the Island Park Ministry because of Bylaw 3.9.5.4.1 of the LCMS Handbook. It states, "Pastors and congregations must avoid membership or participation in any organization that in its objectives, ceremonies, or practices in inimical* to the Gospel of Jesus Christ or the faith and life of the Christian church." [*inimical: adverse in tendency or effect, unfavorable, harmful.]
- Also recently, the Seventh Day Adventist Church was added as a member church even though some question whether that organization is truly Christian or not.

Therefore, it is proposed that Hope Lutheran withdraw its membership from the RCCM. This is being brought before the voters of the congregation because, according to the Constitution and By-Laws of the Regional Council for Christian Ministry, Inc., "The membership in RCCM may be withdrawn by the governing body of the congregation at any time."
