# Hope Lutheran Church Special Voters Assembly February 16, 2025

A special meeting of the Hope Lutheran Church voters was held on February 16, 2025. The meeting was called to order at 10:46 a.m. by the vice president, Kurt Pavlat. The secretary was also present. A quorum was established; a list of voting members present is attached. The purpose of the meeting was to 1) review the recommendation from the Call Committee for the Headmaster/Associate Pastor position; 2) vote whether to issue a formal Call to Reverend Brennick Christiansen if desired by the voters; 3) adopt the Resolution to borrow up to \$1,400,000.00 from the Lutheran Church Extension Fund (LCEF); 4) vote whether to elect Lori Stanger as Property Director.

As this is a special meeting, the only items of business are those listed above.

Pastor Pray read a portion from Jeremiah 17 then led the opening prayer.

Christopher Becker moved, and was seconded, to accept Lori Stanger into voting membership. The motion carried unanimously.

There was discussion regarding the Call Committee's recommendation to extend a formal Call to Reverend Brennick Christiansen for the Headmaster/Associate Pastor position. Pastor Pay reported that the position would be two-thirds Headmaster and one-third Associate Pastor. The Call Committee moved to extend a formal Call to Reverend Brennick Christiansen and called for a vote. The motion carried. Paper ballots were distributed to the 31 voting members present. David VanHaaften and Roseanne Pavlat counted the ballots, and the following was the outcome: 30 voted yes; one person abstained. Therefore, a formal Call will be extended to Pastor Christiansen. Kurt Pavlat will make a telephone call to the Pastor to let him know that our congregation voted to issue a formal Call to him. The Call papers will be sent to Pastor Christiansen via UPS.

David Van Haaften moved, and was seconded, to accept the Resolution for Hope Lutheran Church and School to borrow no more than \$1,400,000.00 from LCEF. The motion carried. A copy of the Resolution is appended below.

Gary Thinnes moved, and was seconded, to vote whether to elect Lori Stanger as Property Director. The motion carried. Paper ballots were distributed to the 31 voting members present. Sophia Helmkamp Hynes and Matthew Rose counted the ballots, and the following was the outcome: 29 voted yes; two abstained. Therefore, Lori Stanger was elected as Property Director. Congratulations, Lori.

There being no further business, the meeting adjourned at 11:21 a.m. and we closed with the Lord's Prayer.

2. That the said loan be secured by a Mortgage or Deed of Trust with respect to all of the real property owned by the Borrower described as follows:

That the legal signers as specified in the Articles of Incorporation and/or the Constitution and Bylaws of the Borrower or, if not specified, the President and Secretary or, in the absence of the Secretary, another Officer, of the Borrower are hereby authorized, empowered and directed to execute, acknowledge and deliver on behalf of the Borrower a Mortgage or Deed of Trust, and one or more Promissory Notes as above provided and said Officers are further authorized, empowered and directed to do all such acts and things to execute and deliver all such documents as may, in the discretion of said Officers be deemed necessary, proper or convenient to carry out and comply with the provisions and terms upon which said loan is being made to the Borrower and the same are hereby approved in all respects.
